- ▶ SSC initiation: Bandung, Indonesia: 1st Asia Africa Conference, April, 1955
- ▶ Attended by 29 independent countries representing more than half global population

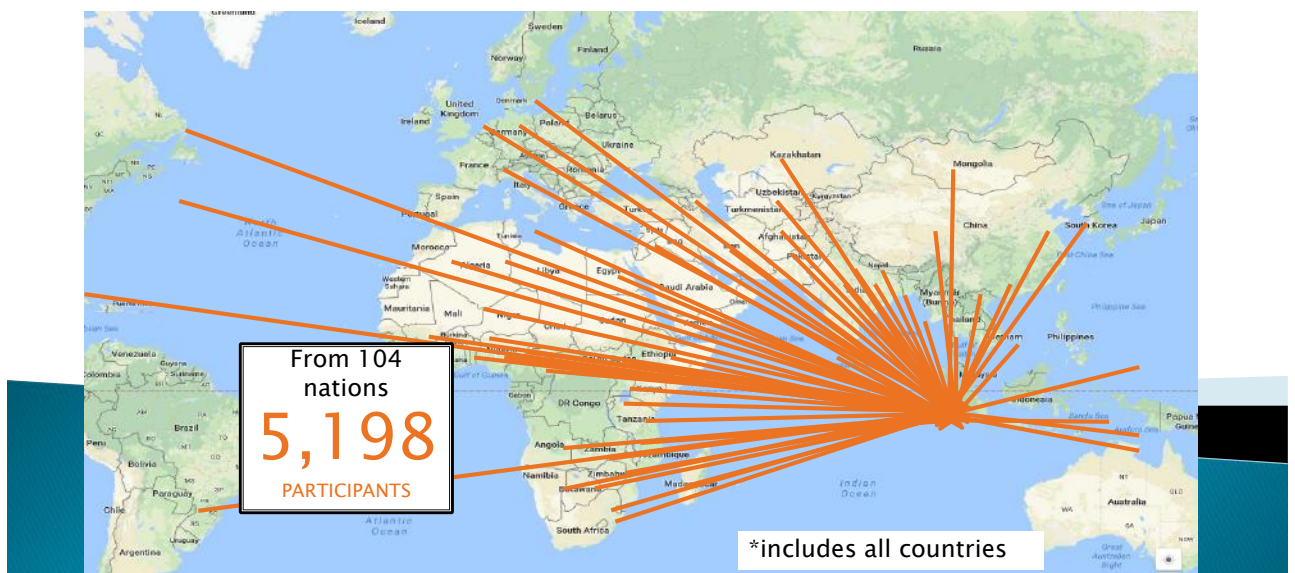

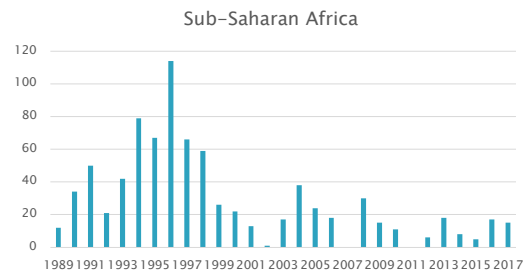
